Admission procedure for MBA

This examination OJEE MBA is conducted by Odisha Joint Entrance Exam Board at the state level in the beginning of academic session every year.

OJEE MBA Eligibility Criteria

The aspirants have to fulfil any of the three criteria listed below to take admission into the post graduate course MBA.

- Completed graduation (in any discipline) of minimum three years' duration from any university or a recognised institute or university outside Odisha but defined by UGC or AICTE. The minimum passing marks in this case must be 50 per cent marks (45 per cent in case of aspirants belonging to SC/ST category) at the qualifying exam.
- Hold a Bachelor's Degree in Engineering/Technology/Architecture/Pharmacy programmes of four – five years duration from any University of or a recognised institute or university outside Odisha but defined by UGC or AICTE. The minimum passing marks, in this case, must be 50 per cent marks (45 per cent in case of aspirants belonging to SC/ST category) at the qualifying exam.
- Be in the final year of their graduation to be able to apply for OJEE MBA. N.B.: There is no prescribed age limit for applying to OJEE MBA.

Admission procedure for B.Tech Engineering

Admission into B.Tech courses of the Biju Pattnaik University of Technology (BPUT), Rourkela, Orissa shall be based on criteria decided by the academic council of the University. There shall be provision for direct admission for a limited of NRI students. The University (BPUT) and the examination conducting authority Odisha Joint Entrance Examination shall adopt the eligibility criteria as specified by AICTE.

The student should at least have qualified in one of the entrance examinations of JEE (Main) or OJEE.

Admission of a total 75% of seats in B.Tech courses are taken from the merit list of OJEE conducted by Govt. of Odisha and 15% from AIEEE conducted on all India basis by CBSE , New Delhi , Govt of India , how ever the final distribution of seats , as per the decision of Govt. Of Orissa Policy Planning Body.

Rest 10% seats will be filled up through JEE (main) candidates and OJEE / AIEEE Rank holders
Odisha Joint Entrance Examination (OJEE) is an entrance examination for admission to a number of professional courses in engineering and etc in the professional colleges of Odisha . The entrance test (JEE) for admission to B.Tech programmes is held in the subjects Physics + Math (mandatory) along with Chemistry, Bio-technology, Biology, Electronics, Computer Science, I T, Geology, Statistics (Any One subject) minimum 45% aggregate

Eligibility Criteria:

ODISHA JEE (Main)

A candidate should have cleared or have appeared in class 12 exams with Physics, Mathematics and one of the subjects from Chemistry / Computer Science / Biotechnology / Biology. Engineering Diploma Holders can also appear for the exam. The Minimum % of the qualifying examination is 45% for the above criteria students Or for more information regarding admission through Orissa JEE please visit www.odishajee.com, www.ojee.nic.in

JEE (Main)

The minimum academic qualification for admission through AIEEE 2012 is a pass in final examination of

10+2 (Class XII) or its equivalent referred to as the qualifying examination (see Appendix - VIII). Those appearing in 10+2 (Class XII) final or equivalent examination may also appear in AIEEE 2012 for consideration of provisional admission. The Minimum percent of the qualifying examination is 45% for the above criteria students.

Admission procedure for Diploma in Engineering

Eligibility For Admission To First Semester/ First Year Diploma In Engineering The Selection Criteria Is As Listed Below:

- Pass in HSC examination conducted by BSE, Odisha/ 10th standard examination declared equivalent by BSE, Odisha and obtained at least 35 % marks in aggregate, securing 30% marks in each subject at the qualifying examination with English, Math & Science subjects.
- Admissions to 1st semester Diploma Engineering Courses shall be made according to the merit rank

drawn on the basis of the marks obtained by a candidate in the qualifying examination through web based e-counselling.

ELIGIBILITY FOR ADMISSION TO 3RD SEMESTER DIPLOMA IN ENGINEERING UNDER LATERAL ENTRY:

- Pass in +2 Science Examination from CHSE, Odisha or its equivalent examination with PCM / +2

Vocational (2 years course) in any Engineering Trades /2 years ITI in Engineering Trade/COE Trade with

pass in HSC examination conducted by BSE, Odisha/ 10th standard examination declared equivalent by

BSE, Odisha securing 30% marks in each subject at the qualifying examination.

- Admission to 3rd semester Diploma Engineering (Lateral Entry) shall be made according to the merit rank drawn on the basis of the marks obtained by a candidate in the qualifying examination through web based e-counselling.

N.B.: AGE LIMIT: - Lower age 14 years and Upper age – No bar

Admission procedure for M.Tech

The only examination “OJEE PGAT” is to take admission into the Engineering Post Graduate course M.Tech. This examination OJEE PGAT is conducted by Odisha Joint Entrance Exam Board at the state level in the beginning of every academic year.

OJEE PG Eligibility

Admission procedure for IMBA

ELIGIBILITY FOR ADMISSION TO INTEGRATED MBA (5 Years Course). THE SELECTION CRITERIA IS AS LISTED BELOW:

- Passed 10+2 examination of CHSE, Odisha or equivalent. The candidate should have passed all the individual subject and must have obtained at least 45% marks (40% in case of candidate belonging to SC/ST category) in all the subjects taken together.

- Admission to this course will be made from OJEE rank first and if seats are vacant admission will be done

on the basis of +2 mark of Science, Commerce and Arts streams. For remaining vacant seats Diploma

Engineering students and students passed in +2 vocational courses will be allowed for admission.

- In case of non availability of students from one stream, remaining seats in that stream may be allotted to students from other two streams on equal basis. In case of non availability of students from two streams, remaining seats in those streams may be allotted to students from third stream.

N.B.: There is no age limit to appear at OJEE test for admission into Integrated MBA courses


